Introduction

Content Guidelines

The introduction contains the opening text for the main body of the manuscript. It should include a statement of the problem or situation and the approach to resolve it. This first section may also summarize the past developments and background of what is already known or published elsewhere. This is best summarized in your paper, referencing other publications containing more extensive discussions of this background information. All references are placed at the end of the paper.

Remember that you should not re-state material readily available in the archival literature. Simply summarize it, and then add a reference or two.

Acceptable Computer Files

Each manuscript must be uploaded as a "Camera-ready" PDF file and Word document. You can use other programs to prepare your manuscript, but you must follow the formatting specifications outlined in the template and upload it as a PDF and Word document.

General Formatting Guidelines

Following these guidelines in detail is essential to ensure a high-quality proceeding can be produced efficiently. Each manuscript must be non-commercial, submitted in English, and be a maximum of 5 pages.

The manuscript components are (in order of appearance):

1. Paper Title and Blurb	7. Conclusions
2. Authors' Names	8. Acknowledgments
3. Keywords	9. References
4. Introduction and Background	10. Appendix (if any)
5. Experimental Procedures	11. Authors' Affiliations

6. Results and Discussion

Paragraphs are not indented but are separated with 6-point spacing. Use only one space between sentences. If you forget and use two, you can use the Edit/Replace function to correct it. In the "Find What" box, hit the space bar twice. In the "Replace With" box, hit the space bar once. Click on "Replace All".

Font

Please select Times New Roman for the font of all text in the manuscript except for symbols that require an alternate font. Please keep the font size of the components as they are presented in this template (i.e., 14 bold for title, 12 bold for component headings, 10 bold italicized for authors, 10 regular for the body of the components, etc.).

Margins

Your text should flow completely to the foot of the page. Margin requirements are listed below. Please note that the top margin for page 1 of the manuscript differs from the top margin for subsequent pages.

Experimental Procedures

Content Guidelines

Explain the initial steps in your preparation and analysis.

Figures and Tables

Figures (only 3 to 4 of them) and tables (only a limited amount) should be placed to allow text to flow around them. If they are created in a spreadsheet or graphics program, simplify them for readability. If necessary, reduce them to fit into one column, or center them to fit across both columns and resume the two-

column format. Type the figure number and caption after each figure. The figure number must be referenced in the text. All images and their captions must be center-aligned.

Before each table, type the table number and caption. The table number must be referenced in the text. All tables and their captions must be center-aligned.

Embedded and Attached Images

All images contained in the manuscript must be **embedded** in the file and of print resolution (300 dpi). Also, high-resolution images in jpg or tiff formats must be provided.

Use 24-bit color image files for the most accurate color representation. This is especially important if color blending or gradients are used. Black and white images should be grayscale image files to eliminate unnecessary color information and minimize the file size.

Photographs, Scanned Images and Other Images (Bitmap Graphics)

Color or black-and-white photographs and scanned images are acceptable if embedded in the file. Acceptable bitmap graphic file formats are EPS (preferred), TIFF, PSD (Adobe Photoshop), and JPEG (low-resolution JPEG files will produce poor print-quality images). Please remember that the bitmap resolution will determine how well your graphic appears in print. Likewise, the bitmap resolution should be 300 dpi.

Using the Spell-Checker

Proof your document for spelling errors. If you struggle with the spell-checker in Word, select Review (or Tools for older versions)/ Language/Set Language. Verify that the language is set to English and that the box to detect language automatically has not been checked.

Print-ready Copies

Your manuscript should be submitted online in "Camera-ready" condition. Figures, tables, and text should be placed appropriately, and all margin guidelines should be adhered to. Your manuscript will need to be converted into a PDF file. Since errors sometimes occur during the PDF conversion process, all files must be **carefully proofed** to verify integrity compared to the original manuscript. Please pay extra attention to reviewing any symbols that may require the font used to be embedded with the pdf file to ensure they have been appropriately converted.

Place acknowledgments here, if needed.

These should be limited. Literature references are numbered in the order of their appearance in the manuscript and are confined by brackets. They are listed at the end of the manuscript using the format shown here.

Remember, your research's readability, overall quality, and presentation are in your hands. Please prepare a high-quality manuscript that will be an excellent contribution to *WJRS Letters*.
